### **Agreement:**

This Agreement is formed between the stallion owners and the individual/s named in this contract. Upon the mare owner signing this agreement or booking form this will be confirmation of a contract between both parties relating to the service. The only enforceable obligations and liabilities are those expressed & implied in this agreement. Any prior representations, statements or promises in relation to the service are merged within and superseded by this agreement and from this contract.

1. The stallion/s semen is to be used for the named mare only and copies of registration papers will be required. Any misuse of the shipped semen will render the mare owners rights null and void and in this event, the stallion owner may retain any fees as liquidated damage.
2. Semen will only be provided after the non-refundable handling fee of \$650 has been paid in full with the stallion contract signed and received by the stallion owner/agent.
3. The service fee to the stallion is \$1000 plus booking/ handling \$650, fees are non refundable and the handling fee is to be paid in full prior to stallion collection.
4. The full service fee is payable upon a 45 day positive pregnancy test/scan.
5. The mare owner will be responsible for the cost of collection & packing of semen.
6. Transportation costs for the semen are payable by the mare owner. Transport of chilled semen/Frozen to the Brisbane or Gold coast airports by negotiation. Collection of semen on arrival of air freighted is the mare owner's responsibility and cost.

7. All accounts relating to semen collection and any other incidental amounts must be paid in full prior to a service certificate being provided by the stallion owner.
8. Once the semen has been handed over and accepted by the chosen transport provider, The stallion owner accepts no responsibility for the semen or delays in freight to the mare owner/s identified location.
9. It is recommended that you have your mare scanned at your chosen breeding veterinary facility to ensure that she is a suitable candidate for breeding.
  
10. The stallion owners warrant that the stallion is fertile and free from any breeding diseases and shall not accept any responsibility or liability for any mare that will not breed or cannot conceive. In the case of the mare being unable to conceive, all conditions of this contract shall be transferrable to any other mare that the mare owner owns or leases by negotiation. This transfer is only valid for the season that the service was booked or for the following year.
11. A Live foal guarantee will be granted to all mares returning a 45 day positive pregnancy test to Hamlot Park Soprano if all service fees have been paid in full. If the mare fails to produce a live foal up to 48 hours after the birth provided a veterinary certificate is supplied to the stallion owners and a claim for a dead, foal is made no later than 48 hours after the death of the foal. The re-breeding is not transferable to another mare unless agreed to by the stallion owners. However, all costs relating to handling fee, collection and transport costs will have to be paid again as necessary.
12. For a return service, the stud must be provided with a vet certificate stating that the mare is not in foal or that the foal has not survived over 48 (forty-eight) hours, also that the mare was in good health.
13. In the event of death or injury to the stallion prior to breeding rendering him unable to breed, any service/booking fees paid by the mare owner/s will be refunded to the mare owner/s.
14. Agistment is available for visiting mares at a daily rate by negotiation. Any transport, worming/vaccination, reproduction, vet and agistment costs are the responsibility of the mare owner and must be paid in full before a service certificate issued.

15. Usual Veterinary and agistment fees apply. If a mare is neglected and undergoes any veterinary interference, which terminates the pregnancy, this contract becomes null and void.

A new contract is required at the beginning of a new season for each mare.

Veterinary fees are the responsibility of the mare owner. Sirrah Riding Ponies & Hamlot Park reserve the right to call a veterinarian at any time for any reason that in the opinion of the stud is in the best interest of the agisted mare/foal. Sirrah Riding Ponies & Hamlot Park reserve the right to use drugs including antibiotics, sedation and oxytocin in an effort to gain a positive pregnancy test.

#### **Colt Policy :**

A Colt Policy is placed on Hamlot Park Soprano. Clients are in agreeance & accept the service price is greater if a colt is born (unless the colt should be neutered) than it is for a filly.

The Colt, must be neutered within eighteen (18) months from the birth otherwise the client must pay the colt fee. If the colt proceeds 18 months of age and is still a colt said horse must be neutered at the earliest availability or colt policy paid.

Stallion owners reserve the right to request proof of colt neutering, acceptable proof being vet report of gelding.

Any progeny born to Hamlot Park Soprano either via artificial insemination, frozen or live cover (including embryo transfers) client is in agreeance once this contract is signed, an additional \$45,000 is payable on top of the service fee and handling fee, if the mare covered produces a colt & said client owner wishes to retain colt. This is to be paid in full before the colt reached 18months of age or all colts are to be gelded prior to reaching 18 months from DOB. Unless otherwise discussed with Bobby, Melody, Ashley & mare owner.

If the client sells, leases or reassigns the resulting progeny colt to any other party (Australia or world wide) prior to gelding, the client agrees that prior to the sale, lease or reassignment of said progeny, (including Embryo transfers) the colt policy fee must be paid in full to stallion owners or gelded. If the above mare is sold prior to foaling a new contract by purchaser must be signed before a service cert is provided. Signing of this stallion contract for Hamlot Park Soprano by named client, is confirmation that said client understand all of the stated conditions and agrees to be legally bound by them.
